



Admissions Policy

West Coventry Academy is an Academy within Arthur Terry Learning Partnership (the Academy Trust) and the Academy Trust is the admission authority. It participates in Coventry City Council's (the Local Authority's) Co-ordinated Admissions Scheme for Year 7 admissions intake. The admission arrangements comply with the Fair Access Protocol as detailed in the School Admissions Code.

For September 2027, West Coventry Academy's Published Admission Number (PAN) for Year 7 is 240.

If there are more requests for the school than there are places available within the school's admission number, places will be allocated in accordance with the following criteria and in the order shown below:

1. Children who, at the time of admission, are in care of a Local Authority or are provided with accommodation by the Authority (Looked After Children). Also, all previously Looked After Children, including those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted or became subject to a residence order or a special guardianship order.

A Looked After Child is defined in Section 22 of the Children Act 1989.

2. Children who live in the catchment area served by the school, who have a brother or sister attending the school provided that the brother or sister will be of compulsory school age and will continue to attend West Coventry Academy the following year.
3. Other children who live in the catchment area served by the school.
4. Children living outside the catchment area with a brother or sister who currently attends West Coventry Academy, provided that the brother or sister will be of compulsory school age and will continue to attend the following year.
5. Children by reference by distance to the school.

If it is not possible to meet all of the requests in any one of the categories described above the school will prioritise the requests by reference to distance.

BROTHERS AND SISTERS

6. The Trustees of the school see the benefits of children from the same family attending the same school and give priority to brother and or sister connections in its policy for allocating places. The definition of brother or sister includes stepbrothers, stepsisters, half-brothers, half-sisters and adopted brothers and sisters living at the same permanent address. However, where the school is oversubscribed, no guarantee can be given that places will be available for brothers and sisters.



Where the final place in a year group is offered to one of twins or other multiple births the parent has to decide which child will take up the place.

COMPULSORY SCHOOL AGE

7. Brothers and sisters are required to be of compulsory school age within the over-subscription criteria. This means they must be attending in Years 7 to 11 at the time that the applicant would be joining the school.

DISTANCE

8. If it is not possible to meet all of the requests in any one of the categories described above, the priority will be determined by the proximity of the child's home to West Coventry Academy. This will be carried out using a straight line measurement and a computerised mapping system, from the centre of the child's residence to the centre of the school site. The address used must be the child's permanent home address. The shortest measurement will have the highest priority. Where the final place in a year group can be taken by two or more children living an equal distance from the school, the admission authority will select by drawing lots. As stated by the School Admissions Code, random allocation processes must be supervised by someone independent of the school.

HOME ADDRESS

9. A student's home address is considered to be a residential property that is the child's only or main residence. At the time places are allocated, proof of permanent residence at the property concerned may be required. Where documentary evidence can substantiate to the satisfaction of the admission authority that care is split equally between parents at two homes, parents must name the address to be used for the purpose of allocating a school place.

For children of UK service personnel or Crown servants returning from overseas with a confirmed posting, the admission authority will use the address at which the child will live when applying the oversubscription criteria, provided that parents supply appropriate evidence of their intended address. Where a parent requests this, a Unit or quartering address will be accepted as the child's home address for the purposes of applying the oversubscription criteria, in accordance with paragraph 2.21 of the School Admissions Code.

If a school place is offered on the basis of an address that is subsequently found to be different from a child's normal and permanent home address, then that place is liable to withdrawal.



CATCHMENT AREA

10. One of the aims of West Coventry Academy is to serve its neighbourhood and develop links with the local community to strengthen the school and community. The area served by a school is known as the catchment area and details of our catchment area are at Appendix 1.

SPECIAL EDUCATIONAL NEEDS

11. All children with an Educational Health and Care Plan that name the school will be admitted before all other applicants.

LATE APPLICATIONS

12. The closing date for admissions in the normal admissions round is 31st October. After that date the Local Authority will continue to receive applications but those will be considered to be late and may not be processed until after the 1st March the following year.

APPEALS

13. If parents are unsuccessful in obtaining a place, they have the right of appeal against the decision not to allocate your child a place. Accepting the place you have been offered does not affect your right to appeal. Appeals are coordinated by the Local Authority, this applies to both in-year appeals and year 7 (2027) allocation. WAITING LISTS

15. After the initial allocation of places, the Academy will establish a waiting list up until the end of the Autumn Term (31 December). Parents who wish to continue to be considered for any places at West Coventry Academy after the end of the Autumn Term must register their interest via the Local Authority by completing a Secondary School Transfer Application Form. A new waiting list will be produced at the start of the spring term which will then operate until the end of the academic year. The admission authority will maintain a waiting list until at least 31 December of the school year of admission. The waiting list will be ordered in accordance with the published oversubscription criteria. Each time a child is added to the waiting list, the entire list will be re-ranked in line with these criteria. This means that children may move up or down the waiting list



as other children are added. When a place becomes available the school will contact the first person on the list for the relevant year group.

IN-YEAR ADMISSIONS

16. Parents/carers of children seeking admission to West Coventry Academy should apply for a place by completing a standard admission/transfer application form, available from the school or the Local Authority. Once completed, the form should be returned to the Local Authority which co-ordinates all such applications, and the Local Authority will notify applicants of the school's admission decisions. If a place is not available in the relevant year group, parents are entitled to appeal against this decision (see Appeals, paragraph 13).

APPLICATIONS FOR CHILDREN TO BE ADMITTED INTO A CLASS OUTSIDE OF THEIR NORMAL AGE GROUP (Years 7–13)

17. If parents wish for their child to be considered for admission to a class outside of their normal age group, they should make an application for the normal age group in the first instance. Parents should then submit a formal request to the Governing Body. This request should be in the form of a written letter of application outlining the reasons why you wish for your child to be considered to be admitted into a class outside of their normal age group, and enclosing any supportive evidence and documentation that you wish to be taken into account as part of that request. The Governing Body will consider applications submitted and advise the parents of the outcome of their application before the national offer day, having taken into account the information provided by the parents, the child's best interests and the views of the Headteacher. FAIR ACCESS PROTOCOL

18. The Coventry Fair Access Protocol covers the arrangements for all admission requests and the integration or reintegration to schools of students who are requesting a place at a school and are considered more difficult to place. All secondary schools in Coventry are included in this partnership. The agreement requires each school to accept a quota of students who are regarded as more difficult to place over their published admission number if necessary. This agreement acknowledges the significant additional challenge faced by West Coventry Academy in respect to admissions and provides a fair and equitable framework for the admission of more difficult to place students.
